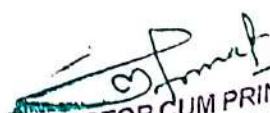
## POLICY OF BOOK BANK SCHEME

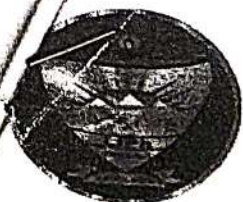
