“CPCSEA guidelines, handling of laboratory animal and animal house maintenance”

The Program started with the lamp lighting ceremony and Saraswati Vandana. **Prof. Dr. Ran Singh**, Managing Director Laureate Institute of Pharmacy welcomed the resource person, **Dr. Sunil Sharma**, Professor in Department of Pharmaceutical Sciences, Guru Jambheshwar University of Sciences and Technology, Hisar, Haryana. He highlighted the importance of animal experimentation in drug, discovery and development process. He motivated the participants to acquaint themselves with the knowledge of CPCSEA guidelines in addition to animal handling.

Prof (Dr.) Mahendra Singh Ashawat, Director Cum Principal and **Prof. (Dr.) Vinay Pandit** , Vice Principal and Dean academics, welcomed Prof Sharma , by presenting the bouquet.

Mr. ShivKumar Kushawaha, HOD, Pharmacology Department organizing secretary of the event presented the overall schedule of the one day workshop on **“CPCSEA guidelines , handling of laboratory animal and animal house maintenance”**. He mentioned that the training consisted of lecture session on CPCSEA guidelines followed by hands on training and live demonstration of handling of some common laboratory animals , feeding of animal and maintainance of animal in animal house .

The lecture session started at 10.00 am in conference hall. Dr. Sunil Sharma briefly summarized mentioned the role of Institutional Animal Ethical Committee (IAEC) and Committee for the purpose of Control and Supervision of Experiments on Animal (CPCSEA) for ensuring ethical aspects of both animal experimentation. He mentioned the guidelines of record keeping and stock registered maintenance at animal house. He mentioned the role of veterinarian at animal house and basic knowledge and formal training required by the veterinarian .He also discussed about standard operating procedures (SOP's) for ethical animal handling practice and breeding of the animals. He mentioned different anesthetic technique in experimental pharmacology and euthanasia techniques and disposal of sacrificed animals. Furthermore, he also discussed

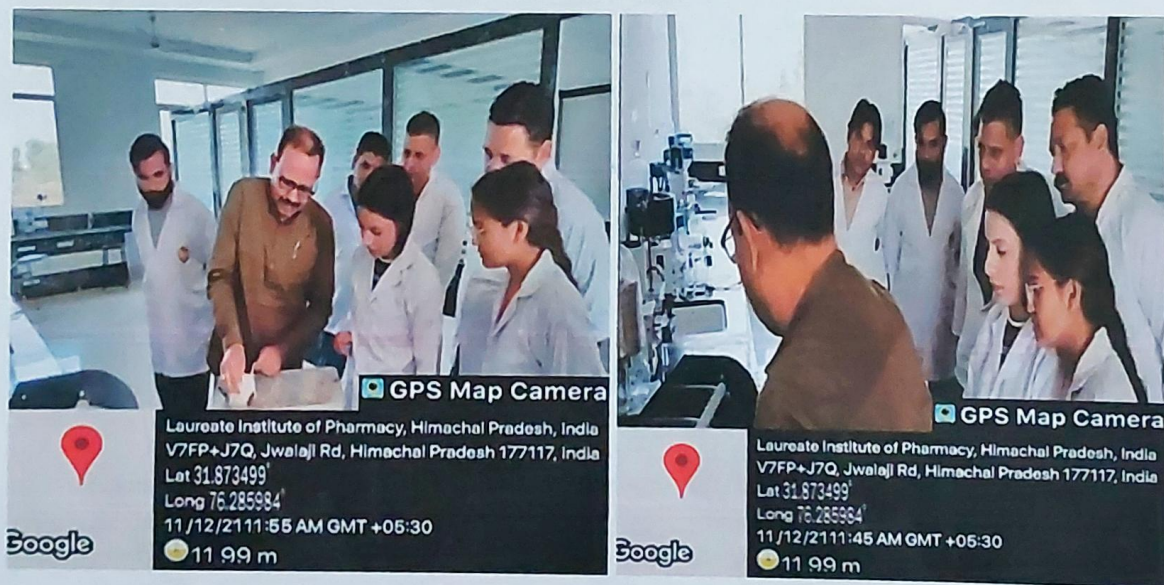

different facilities required in animal house and protocol of animal transportation. He acquainted the participants about maintaining of animal records and type of form like A, B, C, D use in record keepings. He also mentioned different techniques of waste disposal during pharmacological screening. He enriched the participants with knowledge about health indicators parameters of laboratory animals and rat grimace scale(RGS).

In Post lunch session , He explained the basic research facilities available in post graduate, pharmacology department and working and handling of certain equipment's used in animal experimentation such as acto-photometer, pole climbing apparatus, Kymograph drums, isolated organ bath , etc. He demonstrated the handling of common laboratory animals like albino rat and albino mice. He also practically demonstrated the feeding of rat and mice through feeding tube and different route of administration of drug substances.

There was an interactive session with participants where Dr. Sharma solved the queries of participants.

Prof (Dr) Mahendra Singh Ashawat, Director Cum Principal, presented the memento and certificate of appreciation to Prof Sunil Sharma.

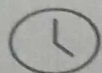
