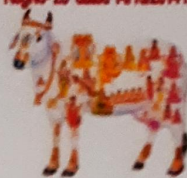

This MOU will commence on the date 14/12/2020 and will remain in effect for Three year. It may be renewed upon mutual agreement.


5. Termination:


