MEMORANDUM OF UNDERSTANDING (MoU) (*Inter-Institutional Academic Collaboration*)

This Memorandum of Understanding (MoU) is made on 23rd January 2026 between **Mar Dioscorus College of Pharmacy**, Hermongiri Vidyapeetam, Alathara, sreekaryam (PO), Thiruvananthapuram-695017, Kerala and **Laureate Institute of Pharmacy**, Kathog (PO), Tehsil Jawlamukhi, District Kangra, Himachal Pradesh, PIN 176031, hereinafter referred to as “the Two Institutions.”

Preamble

The Two Institutions agree to establish academic cooperation to strengthen collaboration in Pharmacy education, research, training, and extension activities for mutual benefit.

Objectives

The objectives of this MoU are to:

1. Promote academic collaboration and curriculum enrichment in Pharmacy programmes.
2. Facilitate faculty and student exchange for teaching, learning, and research.
3. Encourage joint research, publications, and sponsored projects.
4. Organize joint seminars, conferences, workshops, and training programmes.
5. Share academic resources and best practices while respecting intellectual property rights.

Scope of Collaboration

The Two Institutions agree to:

- a) Exchange information on academic and research programmes.
- b) Share teaching–learning materials and scientific literature, subject to IPR policies.
- c) Jointly organize continuing education programmes, FDPs, seminars, conferences, and workshops.
- d) Collaborate in research and training programmes sponsored by funding agencies.
- e) Exchange Undergraduate and Postgraduate students for short-term academic activities on a reciprocal basis.
- f) Respect intellectual property rights; ownership arising from collaborative work shall be decided mutually.

Coordination

Each institution shall appoint a Programme Coordinator. A joint coordination committee shall periodically review activities under this MoU.

Duration and Termination

This MoU shall be valid for three (3) years from the date of signing and may be renewed or amended by mutual consent. Either institution may terminate the MoU by giving three months' written notice.

Financial Clause

If any activity involves financial commitments, a separate Memorandum of Agreement (MoA) shall be executed.

Governing Law

This MoU shall be governed by the laws of India.
