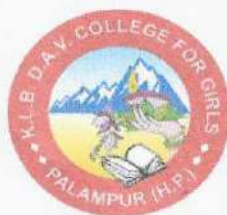


Memorandum of Understanding

Objective of Memorandum of Understanding

KLB DAV College for Girls, Palampur is one of the pioneer institute imparting education to girls in various disciplines. A beacon of knowledge and women empowerment, it has made a creative and meaningful contribution in the field of education in Himachal Pradesh and adjoining states. This prestigious institution is established as Sh. Kanhya Lal Butail DAV College for Girls, Palampur (HP) and currently headed by Sh. B.B.L. Butail, former Hon'ble Speaker Himachal Pradesh Vidhan Sabha as its President.

As a progressive institution it has been our endeavor to keep up with the latest demands of the education system and the society. The college is running successfully various professional and vocational courses like BA, MA, B.Ed, D.El.Ed, B.Com, M.Com, BBA, BCA & MCA for the betterment of girls. These courses have been resounding by success for us with students of all the courses bringing laurels to the institution by securing top positions in different courses during the previous years. The Department of Teacher Education has been accredited with a "B" grade by NAAC. But from the academic session 2024-25 we are in a process to go for NAAC accreditation for the whole college.

Whereas, **Laureate Institute of Pharmacy Kathog Jawalamukhi, Distt. Kangra (HP)** is a private institution operating in the domain of pharmacy education and training and running course like D.Pharma, B.Pharma, M.Pharma and Ph.D.

To promote and support academics and career counseling and development for excellence, the two institutions have agreed upon to sign this MOU for a period of five years and mutually cooperate each other in the following main activities:

- Organizing visits of faculty from Laureate Institute of Pharmacy Kathog & KLB DAV College Palampur (HP) for the purpose of training and development of students with prior approval from both the institutions.
- KLB DAV College for Girls Palampur and Laureate Institute of Pharmacy Kathog will work towards joint academic programmes there by mutually using facilities at KLB DAV College for Girls Palampur and Laureate Institute of Pharmacy Kathog with permissible exchange of information and material for academic purposes and career counseling.
- Utilization of facilities at KLB DAV College for Girls, Palampur for the aforementioned purposes.
- Training of students on facilities at KLB DAV subject to availability of resources.
- Both of the parties mentioned above have agreed upon to collaborate jointly for the mutual benefits of each other and for the further pursual of training, workshops and academic activities.
- Organization of events such as seminars, workshops, conferences, training programs etc.
- Any other objective as agreed upon in writing by both the institutions.

1. Financial Arrangements:

Both the parties acknowledge and understand that all financial arrangements, if any, will be subjected to prior written agreement and availability of funds for each activity undertaken. Unless agreed upon beforehand, each party will be responsible to take care of expenses at their end.

2. Duration renewal:

The Present MoU is signed for five years from the date of signing. Its validity will be from 03.10.2024 to 02.10.2029. Further continuance of this MoU will be subjected to joint agreement and review by both parties to be undertaken before the expiry of this MoU.

3. Advertising and Publicity:

Both the institute may advertise this MoU for information of students, faculty and staff.

4. Modification and Termination of MoU:

This MoU may be modified at any time if circumstances arise which call for any alteration, subject to the approval of both parties. Any party may terminate the MoU giving the other party a written notice of one month in advance.

5. Statutory Compliance:

This MoU solely expresses the intention of both institutions. It is agreed upon that it does not have a legal effect nor creates any financial obligations on either institution.

6. Confidentiality:

Both institutions agree and undertake to keep confidential any information/data exchanged, acquired or shared in connection with any program or activity conducted under this MoU.

7. Governance:

All terms of this MoU are subject to the laws of the Republic of India and acts, statutes and ordinances of both the institutions.

8. Signatures on MoU:

Both the institutions agree to execute the objectives of the MoU within the framework of terms of reference of this agreement.

Based on the above promises the parties put their signatures in this MoU on date 03.10.2024
