- To Promote Research Publications different categories of Incentives are decided:
- Whenever paper is to be communicated to any conference/journal, it is necessary to obtain HOD- perusal.
- II. Whenever paper presentation in conference or seminar is planned, it has to be submitted filled seed money form for receiving grant for the same.
- III. If the conference is National then 5000.00 Rs amount is allocated as seed money for travel.
- IV. If the conference is International then 25000.00 Rs for overseas and 10000.00 Rs for inland international conference is allocated.
- V. As soon as the paper/book gets published in the journal or conference paper gets indexed in SCI/UGC care list /Scopus amount of Rs. 3000.00 Rs to be sanctioned as incentives accordingly to the availability of fund.
  - An incentive for research of post graduate fund is also allocated earlier under SMILE program to promote research among under graduates. The range of seed money will be directly deducted in fee, accordingly to the applicant academic score as well financial status.
  - > Total amount which a paper is eligible for will be divided by 3 to be given away to the authors irrespective of no. of authors in the paper. M. Pharm students / Ph.D. students / UG students will not be eligible for any incentives. No cash incentive will be payable to the authors from other institutes.
  - To Promote Filing Patents

## Eligibility and frequency

Staff member should have filed the patent with the Laureate Institute affiliation and through Process. Any staff member, who is willing to file patent, approaches any registered Office of Patent Facilitation & Consultancy (OPFC) with the invention disclosure form OPFC approaches the panel of patent attorney for vetting the idea and drafting the claims for filing the patent. The draft is approved by the staff members and innovators. The institute and innovators decide their share of commercial benefits while signing the MoU with the Institute, if collaborative IPR is filled.

 Total amount of filling fee will be reimbursed and consultancy charges will be sanctioned after granting patent.

The Office of Dean (Academic and Research) will collate a list of research publications as well as IPR registration/Publish/ grant on the basis of the Half yearly notifications.
