

Memorandum of Understanding

This Agreement entered into on 10/03/2025 between **Laureate Institute of Pharmacy** (hereafter called the **first party** which expression shall, unless it be repugnant to the context or meaning hereof, be deemed to mean and include its successors and assigns).

And

"Rian Dialysis & Health Care Centre, Kathog Jawalaji (H.P.) (hereafter called the **second party** which expression shall, unless it be repugnant to the context or meaning hereof, be deemed to mean and include its successors and assigns)

WHEREAS

1. **"Laureate Institute of Pharmacy, VPO kathog-Jawalaji"** is desirous to have a tie up for Ambulance services for the Patients suffering from chronic kidney diseases.
2. **"Rian Dialysis & Health Care Centre, Kathog Jawalaji"** has expressed its intent to be an associate of **"Laureate Institute of Pharmacy, VPO kathog-Jawalaji"** In providing the **Ambulance** support.

Now, therefore, in consideration of mutual agreements, covenants and conditions herein contained, **"Laureate Institute of Pharmacy, VPO kathog-Jawalaji, and Rian Dialysis & Health Care Centre, Kathog Jawalaji** agree as follows:

1 TERMS AND CONDITIONS

The effective date of this agreement is from 10/03/2025 and the initial term of this agreement shall be a period of one year.

This agreement can be renewed after the expiry on such conditions as mutually agreed by **"Laureate Institute of Pharmacy, VPO kathog-Jawalaji, and Rian Dialysis & Health Care Centre, Kathog Jawalaji.**

2. RESPONSIBILITIES

The **Laureate Institute of Pharmacy, VPO kathog-Jawalaji** will provide Ambulance support to **"Rian Dialysis & Health Care Centre, Kathog Jawalaji."** for the transport of Dialysis Patients.

Non-compliance with any of the above will construe as breach of this Agreement

2 PROHIBITED

Laureate Institute of Pharmacy, VPO kathog-Jawalaji will provide Ambulance support at the nominal rates as per Red Cross Society.

3. TERMINATION

This agreement may be terminated before its expiry by either party by giving 30 days' notice to the other party.

"Laureate institute of Pharmacy, VPO kathog-Jawalaji" shall be entitled to terminate this agreement without any notice in special circumstances which are not in the larger interest of patients.
